The cinemas will be looking to roster the trainees during the busy periods – nights, weekends, school holidays – so availability during these times is a must. They will not be doing the traditional weekly ‘release’ day from school as such, with the weekly hours requirement to be done during those busier times at nights and weekends. This will provide the students a greater learning experience, and complete their hours when the cinemas are at their trading peak!

We are able to qualify the traineeships as school based due to our training model, where the students will complete their training with us onsite at the cinemas, for a full school day, twice per term.

Just in case you are not familiar with our training model, please see below overview:

- **Face to face** training, held onsite at the cinemas
- Sessions run from **9.00am – 3.00pm**, every **4 – 6 weeks** (two sessions per school term)
- No training during school holidays as this is the cinemas peak period
- **All course work completed in class** at these training sessions (nothing self paced or online)
