Enrolment Requirements

Two Forms of ID

Each student must provide two forms of ID, including one of the following:

Clear photos are acceptable and must be uploaded to the enrolment form

- Driver's licence (front and back)
- Passport
- · Birth certificate
- AND a Medicare card (mandatory).
- Students completing CPCWHS1001 Prepare to work safely in the construction industry (White Card) must meet the minimum identification requirements set by WHS Queensland.

Parent/Guardian Consent

The consent section within the enrolment form must be fully completed by a parent or guardian.

Unique Student Identifier (USI)

Please have your USI number ready to upload into the enrolment form.

School Support Letter

A School Support Letter must be provided before an enrolment can be processed.

- Once a student completes an enrolment, their school will be notified by email.
- The school must complete and return the School Support Letter before the enrolment will be finalised.
- If, while completing the School Support Letter, it is identified that a student is also enrolled in a
 Certificate III qualification (or higher) at the same time as completing this Certificate II, a Multiple
 Certificates Letter will also be required. This document will be attached to the email forwarded to
 schools.

Pre-Training Review Form (LLN)

All applicants will receive a pre training Review Form to complete prior to commencement

USI VET Transcript

All students are required to upload a copy of their USI VET Transcript, available for download at www.usi.gov.au.


